

RENTAL AGREEMENT

1. ID: Valid driver's license or passport with photo ID .
2. CREDIT CARDS ACCEPTED: Visa, MasterCard, American Express.
3. DEPOSIT: You must provide credit card or cash deposit for full replacement value of equipment. This covers cost for repair or replacement if necessary. Certificate of insurance also required (see below).
4. INSURANCE REQUIREMENTS: Required on all orders over \$10,000 or credit card to cover deposit. *EDGE grip, LLC*. Must be named "loss payee" and "additional insured". Coverage must include explicitly miscellaneous equipment and rented equipment. Insurance shall be sufficient to cover the cost to repair and/or replace any rented item. Insurance certificate is subject to approval by management before release of equipment. Unless house account is opened, a credit card is required to cover any insurance deductible as well as to guarantee rental payment. Submit attached request form to agent.
5. RESERVATIONS/CANCELLATIONS: Availability not guaranteed without advance notice. Full day rental charge will be applied if reservation is not cancelled 48 hours prior for digital and 24 hours for grip.
6. RENTAL PERIOD: Rentals are charged per day. Weekend charge is counted as one day if picked up after 3:00pm on Friday. A week is charged as 3 or 4 days depending on equipment. Digital equipment rentals are 4-day weeks. One-day rentals are due the following day before 10:00am if picked up before 3:00pm. If equipment is picked up after 3:00pm then the rental starts the following day and must be returned before 10:00am the next day after the rental. Renter agrees to pay for an additional day if any item is returned after 10:00am on the due date for return.
7. RENTER'S RESPONSIBILITY: Renter agrees to examine all items before rental and confirm that items are in good working condition. Renter must operate all equipment according to manufacturer's instructions. *EDGE grip, LLC* assumes no liability resulting from the use, misuse, or failure of any item rented. Renter agrees that if item is defective or unsuitable for their needs, Renter will have no claim against *EDGE grip, LLC*. Upon any damage of equipment, renter agrees to repair items or reimburse *EDGE grip, LLC* for value of repair as well as be charged for the daily rental rate until item is returned. Upon loss or theft, renter will be charged at the day rate on the equipment that is lost or stolen until *EDGE grip, LLC* is reimbursed for the replacement cost. Renter agrees to return all items in the same condition as delivered on or before 10:00am on the due date for return listed on rental form.
8. TERMS: 10 days from receipt of statement for account holders. All rental fees and any other charges to *EDGE grip, LLC* are subject to 1.5% per month finance charge on all overdue accounts. *EDGE grip, LLC* may also charge any outstanding amounts due to the Renter's credit card. Renter agrees to pay for any and all charges incurred in recovering items not returned and recovering rents not paid (including all collection fees, court fees and reasonable attorney's fees and all other cost of collection should such proceedings become necessary). Renter agrees that *EDGE grip, LLC* may enter onto any premises for the purpose of obtaining unreturned equipment within peaceful reason.

ALL ITEMS RENTED ARE NOT INSURED BY *EDGE grip, LLC*.

ALL LIABILITY, REPAIR AND REPLACEMENTS COSTS ARE THE RESPONSIBILITY OF THE RENTER.

THIS DOCUMENT SETS FORTH THE AGREEMENT IN FULL BETWEEN *EDGE grip, LLC*. AND RENTER. THIS IS ONLY MODIFIABLE IN WRITING, SIGNED BY BOTH PARTIES.
